- iv. Candidates must also bring all relevant original certificates/documents along with photo ID proof for verification at the time of interview. The hard copies of duly filled in application with signature and self-attested photograph pasted on it along with all required self-attested copies of the certificates/documents will have to be submitted at the time of written test/presentation to the college authority.
